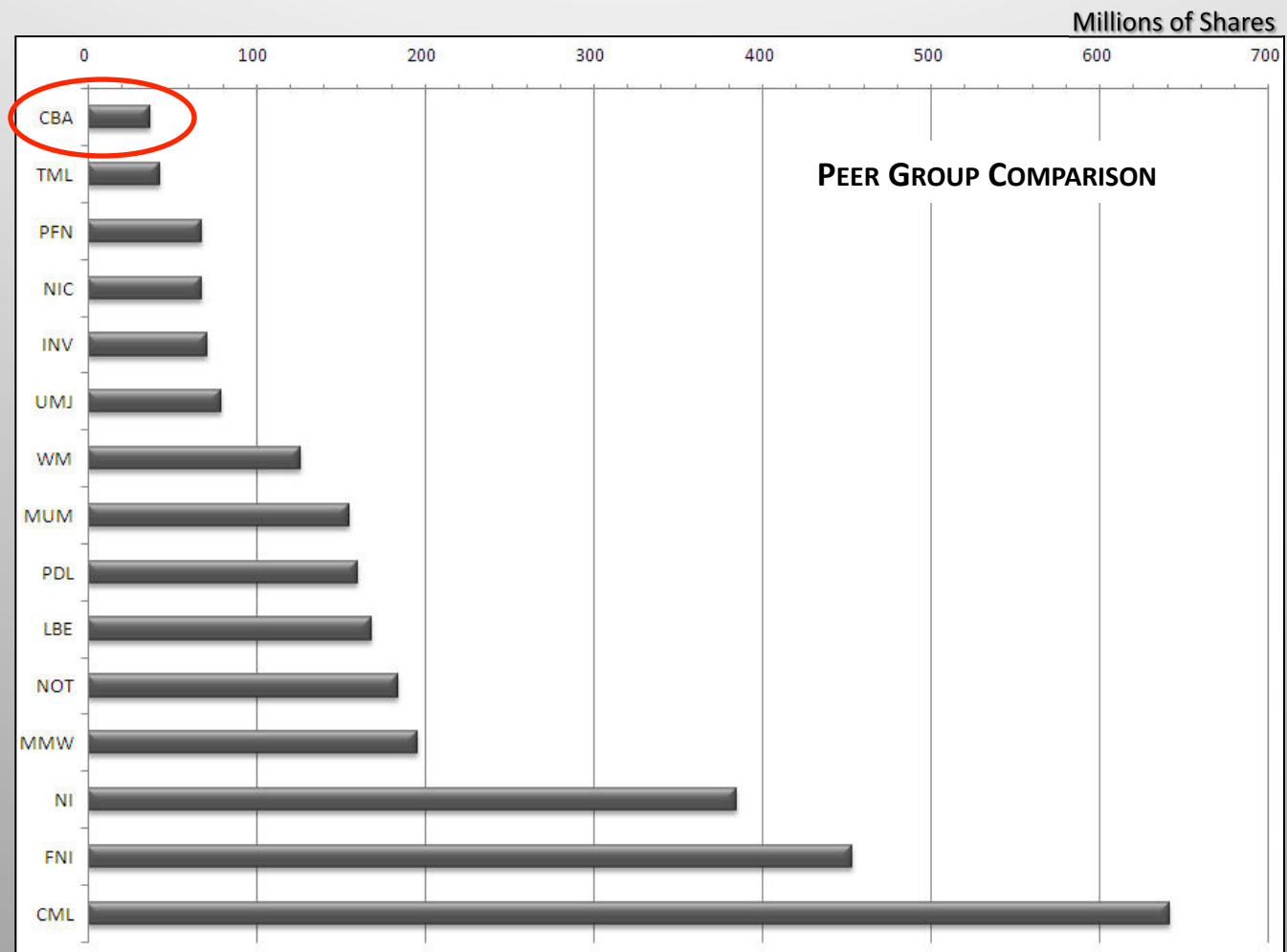

**10 year Charts**

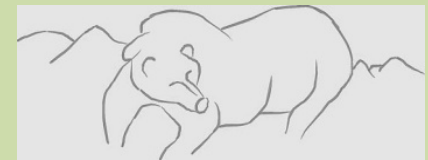

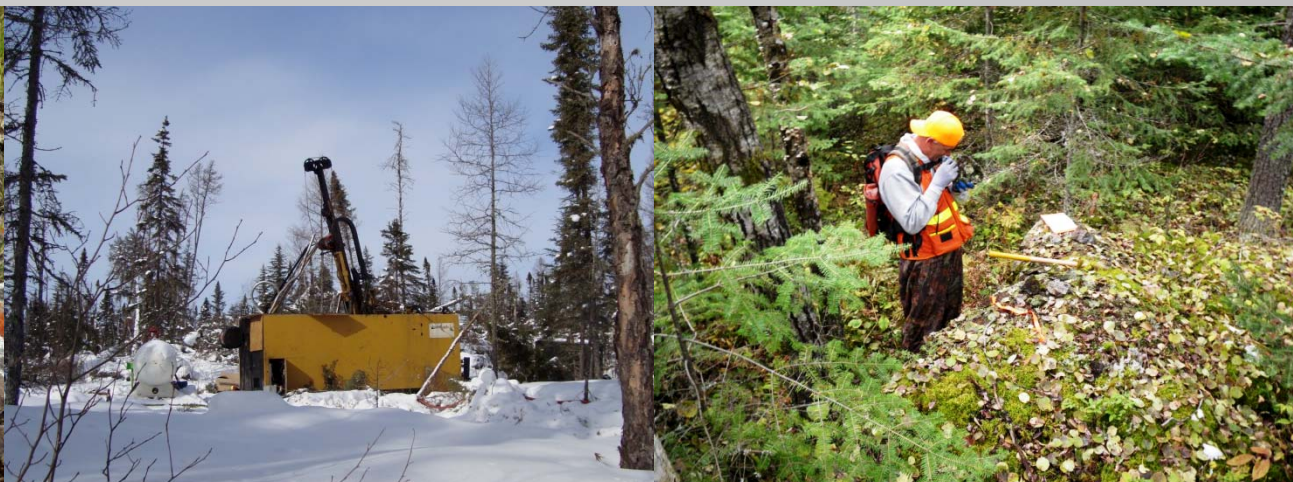
